#### PRESIDENT'S MESSAGE

We are at the beginning of spring and that brings with it warmer days, tree buds popping (and spring allergies), azaleas budding and blooming along with many other colorful flowers and plants. Now is the time we all are trying to get our yards and houses in shape for the seasonal activities. One thing that has always attracted me to our neighborhood is how great we as residents and property owners do in keeping up our property. This has been, continues to be and always will be one of the best and greatest neighborhoods in the city of Norfolk to live. I am always proud and glad when I return from wherever I have been to be home again in my Wards Corner neighborhood. We all must endeavor to keep our neighborhood this way despite the negative pressures being placed on the entire area by the blight that continues to persist to the east of us on Little Creek Road and in the business district.

But things are improving. Last month I wrote about a letter that was sent to the members of city council regarding Wards Corner urging them to do several things immediately. Well it seems that our stern voice was heard and now most of these issues are being addressed.

- The revitalization plan for the Denby Park/Monticello Village/Oakdale Farms neighborhoods is now in the works and the MOU between the city of Norfolk and NRHA should be signed soon. This will enable more revitalization efforts to move forward for the property owners in those areas.
- 2. City Council has now approved the purchase of the three Alexis apartment buildings on W. Little Creek Road. These buildings should be torn down over the next few months.
- 3. The infrastructure is slowly being upgraded in the business district area. The new mast arm traffic signal lights are almost complete and should be operational soon. The utility line improvements are nearing completion on Burleigh, Maycox, North Shore and Newport. Hopefully, we will see repaving of these streets once that is complete. Look for move improvements in the business district area in the coming months.
- 4. The new Police Station is still in the plans for the central business park. We should see a new police station in a few years.

We are told that there are many developers interested in the area and that we should see some major project announcements soon in the business district and along E. Little Creek Road. We also see evidence of improvements in the Titustown area. Perhaps we have turned the corner on our efforts to reinvigorate the area. I remain optimistic, as I need a closer nice place to buy a shirt and tie like I use to be able to do in Wards Corner.

Finally, I have said this several times before. Many of us have been working with the Greater Wards Corner Partnership and its working group, the Wards Corner Task Force, for over 10 years. We have accomplished much in that time period and will continue to work in the future to improve the area despite this latest significant setback. However, since the voices of many carry a greater influence with our elected officials, I am asking that each of you consider becoming a part of these groups. The Greater Wards Corner Partnership

#### **HIGHLIGHTS FROM OUR SECRETARY'S MINUTES**

March 17, 2008

Wards Corner Civic League met on Monday, March 17, 2008 at NFWC at 6:45PM. 30 members attended on this St Patrick's Day eve. After introductions, President Jim English led The Pledge of Allegiance. Ray Duron, Treasurer, and AdoptASpot Chair, announced an area "clean up" along Ruthven Rd. and W Little Creek Road on Saturday, March 29 at 8AM. Volunteers are needed. A member requested help for our Wards Corner's Business District deterioration.

State Delegate Kenneth Alexander reported on the General Assembly's latest work in Richmond which included a budget cut of 5% for localities, increased funding for mental health (veterans, brain injuries, psych disorders), seniors support services, consumer protection act and public safety. Delegate Paula Miller spoke on the Homestead Act, transportation, payday lending, senior tax relief, criminal gang problems, sexual assault and abuse, and a revamped accessible Capitol Building. Senator Ralph Northam addressed the Homestead Act, smoking ban in restaurants, the environment and redistricting. Questions of outsourcing, business objections to the Homestead Act, VA Port Authority, tolls, fees for transportation relief, decreased funding for the arts, payday lending, and housing market slowdown were addressed.

PACE Officer Curtis Jackson reported for our area: an increase in car break ins for GPS and IPODS, 6 larcenies from vehicles, stolen license plates, 2 vandalisms, 1 commercial burglary and 2 stolen vehicles.

President English encouraged members to become involved in the WC Partnership meeting held 7PM-8PM each fourth Thursday in the Workforce Development Center near Kroger's and he announced an April 21 Forum with speakers, Councilman Barclay Winn and opponent Jack Stiles. City Council elections will be held this May. Jim, reporting for the WC Taskforce and WC Partnership, stated 1) City Council's purchase of the Alexis Apartments in Titustown to increase the parking lot size of the Recreation Center, 2) expectations for economic development in the Denby Park area and an impending hotel deal, and 3) the likelihood of a CVS Pharmacy at the BP station site. The meeting was adjourned at 8:15PM.

It is unlawful for any person over the age of 18 years who resides in the city, to operate or use a bicycle upon any sidewalk..., or for any parent to allow a person under the age of 18 years to use a bicycle... unless it has been properly registered. (Code 1958, section 8-2.)
