In order to begin the process of moving forward with the Collins' proposal, a few of us met with the City Planning Director and Zoning Administrator. We did this to discuss how we can proffer an agreement with Mr. Collins and include what we want to see when this plan does get approved. This of course means that we want to ensure that what he proposes is indeed what is ultimately built on the site. It is our intention to keep all interested parties informed and updated as we move forward with this process. To that end, all of Mr. Collins' new proposal documents are now posted on www.wardscornernow.com and www.wardscornernow.com and www.wardscorner.com. I would encourage anyone with an interest in this project to visit the website and post your comments about his new plan.

Wards Corner Civic League Minutes

October 18, 2010

Wards Corner Civic League met on Monday, October 18, 2010 at 6:45PM in NFW Center. President Jim English led us in The Pledge of Allegiance. Attendance: 20. Jim acknowledged the death of a longtime valued member, Mike Trempler.

Our new Community Resource Officer, Odell Davis, who worked in the past with now retired Officer Jackson, reported crime stats (9 larcenies... GPS, cameras, purses, license plates from cars, 5 burglaries) and addressed questions of observing suspicious persons in the neighborhoods (call police 911), Granby High truancy, lighting after 9 PM in WC area, parking on the grass, loitering in WC and at the Post Office and the Tag Out program (Maycox Avenue graffiti). Speaker for the evening was George E. Schaefer, one of 5 Constitutional Officers, who is Clerk of the Court (term 2003-2011). He is the spouse of Delegate Paula Miller. This Circuit Court department handles election returns,

marriage licenses, divorces, deeds, jury duty, court dockets, passports, wills, estates, concealed weapons. His staff of 51 has a \$2 million budget, opens from 8:45AM – 4:45PM daily, and has a huge docket (2nd highest in the state). He pledged to run the department like a business, frugal and efficient, modernize, spend money to save money and work to reduce labor costs. He cut 18% of staff, digitalized/computerized files and docket, uses Face book and Twitter, and has a kiosk available to patrons. Schaefer believes he may return money (\$150-200,000) to the State this year and was complimented by a member as having "the best run office".

President Jim gave an update on the Collins Property. Another meeting with some WC members is scheduled that week. The 4 Kids Charity will open a thrift store in the old K&K Toys site. Are we opposed? No, as long as a decent storefront is maintained. (Better than a vacancy). The Pulse has reopened in the former Nutty Buddy space as a new dining club establishment with new music, menu and clientele. The owner also maintains The Green Onion on Colley Ave. Off duty police will provide security.

The 12 flowering planters in the business district are to arrive the week of October 25. More volunteers are needed to "adopt" a planter to water once each week. Council reps will inquire about the nonfunctioning median Irrigation system and the cracked asphalt parking lot in the Auto Zone area.

The meeting adjourned at 8:10PM.
