PRESIDENT'S MESSAGE

Dear Neighbors,

As fall approaches, so does election season. At our October meeting we hope to bring all of the candidates who represent us in our civic league area to our meeting. We are inviting the candidates who are running unopposed as well as those who are running with opposition. Invited are Delegate Kenneth Alexander and new Delegate Lynwood Lewis who is replacing Paula Miller as a result of redistricting. We are also inviting Senator Ralph Northam who is running against Ben Loyola. I am asking them to debate the issues for our area in a structured forum format as we have done before in our candidate forums. I am hopeful all of these folks will come to our civic league meeting.

At our September meeting I discussed the rumor and non-rumor mill that has been circulating around Wards Corner regarding future development in the business district. While I don't want to beat a dead horse, I do want to share with you what I said at that meeting for those of you not in attendance. So here it is.

It was reported in the Virginian Pilot on September 15th that an Upscale Grocery Store was coming to Wards Corner. You may remember the headline.

"Harris Teeter to Wards Corner?

September 15, 2011

The Virginian-Pilot is reporting that Chris Perry has plans to begin demolishing a dilapidated shopping area in Wards Corner within six months. He would replace it with a shopping center anchored by Harris Teeter."

While we have known for some time that Mr. Perry does have plans for making extensive changes to his property, most, if not all of what is out there regarding his plans is rumor until he makes the announcement. Unfortunately, the civic league president from Suburban Acres Civic League made this announcement at his September meeting that was also attended by the reporter who broke the story in the Pilot. The problem with breaking this story is that it is not from Mr. Perry himself. If indeed he is negotiating with Harris Teeter to build a store on his property and the deal is not complete, the irresponsible release of this information, whether true or not, could kill the deal. That would be very unfortunate.

What is not rumored and also verified by me is that most, if not all, of the tenants on his property have been given 6 months leases and must vacate their businesses after their lease expires. Some may stay longer until the changes to the property are complete or under way. I also know that those current tenants that I have talked to plan on staying and relocating in the Wards Corner business district.

Therefore, what we know is that Mr. Perry is planning on redeveloping his property – and soon. What we don't know is who will be there and what the new Perry shopping center footprint will look like. It is exciting to know that Mr. Perry is moving forward with the revitalization of Wards Corner. We have been waiting for something like this to happen. Hopefully this may encourage other large property owners in the business district to do the same – and soon. Some of them may need that encouragement to redevelop their properties. We can only hope that this will be the start of the revitalization that we have been working on for the past 15 years.

Regardless of whatever happens in the business district, we should be cautious in what we say and not spread rumors about possible land or business deals that may be in the works. To do so may kill any potential deals. It is the responsibility of the property owner to

release this information when they are ready to do so. For anyone else to do so is irresponsible!

Please enjoy the information in this newsletter and I hope to see you at our next meeting.

Wards Corner Civic League Minutes

September 19, 2011

Wards Corner Civic League met on Monday, September 19, 2011 in NFWCenter at 6:45PM. President Jim English called us to order and led the Pledge of Allegiance. He welcomed new members from Bradford and Maycox Avenues and ex officers Gary Ashburne and Linda Spear. Attendance: 29.

Officer Odell Davis reported that within the past 30 days, WCCL had 11 burglaries, 9 larcenies and 2 vandalisms. He noted a situation of an unlocked door, informed us about posting of trespass signage, related that Granby High School students over 18 yrs. may sign self out of school, responded to no follow up to a larceny, stated the area has an unsuccessful

crime/neighborhood watch, and was advised of Sterling Ave. and Arbor Apt. disturbances. Officer Davis encouraged calls to the police if any suspicious activity occurs in the neighborhood.

President English apologized for the absence of our invited speaker, City Manager Marcus Jones, who was on retreat in Suffolk with other council members. Jim announced that the Sewer Pump Station was approved by the Design and Review Committee, and will go to the Planning Commission in October. The project will last 18 months. The City made contracts on 6 apartment buildings in Denby Park and negotiations for a few more are pending, \$2.6 million was budgeted with \$30 thousand extra for closing costs. This was a step in the direction of fulfilling a part of the 2004 Comprehensive Plan for Wards Corner. A newspaper article and rumors suggest the revival/demolition/rehab of the Perry Family SW corner of the business district. There seems to be no certain public deal with a local grocery chain, but present tenants were given notice to vacate by February, '12. Hopefully, higher quality businesses will locate here.

Our October 17 meeting will entertain the two candidates vying for our district's State Senate: Capt. Ben Loyola and Dr. Ralph Northam. Representatives Ken Alexander and Linwood Lewis are expected, also. November- City Manager Jones is re-invited, and in December: our Norfolk Public School Superintendant Other newsworthy items: Surveyors at Bradford and Newport are utility workmen. At Grantham and Restmere, the one way sign needs study by the City. Yellow street markings are absent at the RR tracks near Wendy's and McDonalds, causing traffic problems with left turns.

Martin Thomas, Jr., of the Planning Commission stated that tolls will be added next year to the Midtown Tunnel improvement project (\$1.64 and \$1.84 peak). Bon Secours/DePaul Hospital is revisiting the plans for the campus architecture, as some are dissatisfied with the present plan. Joan Griffey, Beautification, stated that 6 brick crosswalks (already budgeted) will be rediscussed awaiting results of construction in the area. The repair of the irrigation system (2003) and the landscaping of the median between North Shore Road and Taussig Boulevard on Granby Street are undergoing approval with the Taskforce (Commercial Corridor Fund).

Saturday, September 24 is the Adopt A Spot clean up at Ruthven Rd. and W Little Creek Rd. Ray and Betty Duron are our organizers.

The meeting adjourned at 8:15PM.

Street Lights and Apple Pie

Lots of us boomers played and lived our childhoods according to the cycle of street lights. It must have been part of the American way. Parents across the country called out as they watched children race away on bicycles, scooters and skateboards, "Be home by the time the street lights come on!" Today, working street lights still are critical, especially as a crime prevention strategy.

In 2008, a Department of Justice study thoroughly examined the relationship between increased street lighting and crime. The report concluded, "It is clear that reductions in crime can be achieved by improvements in street lighting and that these reductions will be most worthwhile in high-crime neighborhoods. It is also clear that improved lighting can reduce crime during the day and at night. This suggests that improvements to lighting not only act as a situational deterrent to crime, but can also improve local community cohesion and pride, which in turn increases the willingness of residents to intervene in crime or cooperate with the police. Improved lighting will also send a message to potential offenders that the neighborhood no longer offers easy opportunities for crime." See

http://www.cops.usdoj.gov/files/RIC/Publications/e1208-streetlighting.pdf. Note that the relationship in good lighting and reduced criminal activity extends *even into daylight hours*.

All this emphasis on working street lights is taking place concurrently with fall's dwindling daylight hours, and an increased opportunity for those who would use the dark to disguise their dastardly deeds. As a neighborhood, CPRV needs to have every single street light glowing and every porch light shining at night. Is everyone making a list of non-working street lights? Just tuck a scrap of paper and pencil in your pocket and take a stroll down your own block during one of these cool fall evenings. When you notice a non-working street light, make a note of its number and location and contact the City Cares Number-664-6510.
